Notwithstanding the above, the member agrees that any remedy that he/she may be entitled to shall be solely and exclusively limited to damages in the amount not to exceed the fees actually paid by the member for services or activities associated with the agreement. Any and all other remedies or damages are hereby expressly waived by the member.

Rules and Regulations: Limited Program Members agree to abide by all the membership rules and regulations of the Club which may be issued from time to time either orally and/or written and which may be amended from time to time by management's sole discretion.

Usage: As a Limited Program Member, the purpose of your membership is for the program for which you are enrolled. Use of the facilities are during those assigned specific times as deemed by the program application. Under the Limited Membership, guests are not permissible. Use of the facility outside of the program time is not permissible as well. During the program time, other family members **are not** permitted to use the facility.
